Disclosure & Disqualification Requirements

Pursuant to Government Code Sections 56700.1 and 57009 of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, and 82015 and 82025 of the Political Reform Act applicants for LAFCO approvals and those opposing such proposals are required to report to LAFCo all political contributions and expenditures with respect to a proposal that exceeds \$1,000. LAFCO has adopted policies to implement the law, which are available on the Commission's webpage. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. Additional information may be obtained by calling the calling the Fair Political Practices Commission at (916) 322-5660.

A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.

Dear CALAFCO Membership:

We continue to live in challenging times, dealing with the myriad of disruptive changes thrust upon us and our agencies including navigating our way through the roller coaster ride of the pandemic, the drought, unprecedented heat waves, another record-setting wildfire season, and figuring out how to maintain or increase current services with less resources. We remain proud of you, our members and business partners, who continue to demonstrate courage, resilience and leadership in the face of all these challenges.

As we planned our Annual Conference in Newport Beach for October 6 – 8 this year, and time marched on, it became very clear with only five weeks until the Conference that our registration numbers were going to be at an all-time low, with less than half of our normal attendance. After hearing from many of you, we understand there is hesitancy to travel and gather in large numbers with the various strains of COVID-19 continuing to increase. We are also keenly aware that this year many of you have slashed training and travel in your budgets.

After careful thought and consideration, CALAFCO has decided to cancel this year's in-person Annual Conference which was scheduled for October 6 – 8 in Newport Beach.

The Board met in a special meeting on September 2, 2021 and after considering all the facts (the staff report is posted on the CALAFCO website in the Board of Directors meeting area), unanimously voted to cancel the in-person event this year. The Board of Directors and Executive Director believe CALAFCO has an ethical and corporate responsibility to our members, guests, speakers, and their families. This responsibility includes mitigating as much as possible the spread of the virus and being responsible in our decisions to aid in the containment and protect the health and safety of our members. It also means mitigating any significant financial loss CALAFCO may incur by holding the event.

In addition to our concern for your health and safety, the substantial reduction in attendance would require CALAFCO to withdraw Fund Reserves of over \$33,000 to cover the loss caused by such low registration numbers. At any time, especially in these challenging fiscal times, that is not a responsible financial practice, and we believe we must continue to practice fiscal responsibility as the trusted steward of the Association's finances.

CALAFCO's primary mission is education and providing educational opportunities for our members. The Annual Conference is our signature event and one of the best ways we do that. And, this year is CALAFCO's 50th anniversary. Not holding the event this year is another year away from you, our membership. And we miss you!

We thank those of you who registered or planned to register and attend the Conference. We thank all of you who chose to sponsor this year's Conference. We also thank all our speakers who were busy preparing and working on their presentations. As we take our mission seriously and the program being planned was a good one, we plan to bring as many of those educational and networking opportunities as possible to you in a virtual format.

So, what's next?

CONFERENCE 2021 & 2022

- Staff successfully negotiated moving the 2021 event with the Hyatt Regency Newport Beach John Wayne Airport to next year with no penalty fees, and no increase in the contracted room rate from this year. We will keep the same dates as we had scheduled for 2022 which is October 19 – 21, 2022. The contract for 2022 which was with Tenaya Lodge in Yosemite was successfully moved to 2024 without penalty. Check the CALAFCO website for locations and dates for the next several years.

- We will celebrate CALAFCO's 50th + 1 next year!
- We will work with each of you to refund all registration payments made online in their entirety without any penalties.
- Any registrations received in the mail with a check will be returned (most checks were held and not cashed).
- For any registration checks received that were deposited, a full refund will be issued.
- We will also work with all our sponsors to do the same.
- All hotel reservations at the Hyatt must be cancelled. You are responsible for cancelling your own reservations, and you are encouraged to do that ASAP to avoid any possible late cancellation fee or no-show charges because this was a detail left undone.

DELIVERY OF EDUCATION SESSIONS

- Staff is working to schedule planned sessions (with exception of topical roundtables and legislative update) over the course of the next several months (October through January).
- A full schedule will be published as soon as we have confirmation from all our speakers on this change.

ANNUAL BUSINESS MEETING - BOARD ELECTIONS - BOARD MEETING - ACHIEVEMENT AWARDS - REGIONAL ROUNDTABLES

- The annual business meeting will be held as planned on October 7, 2021 at 9:00 a.m. It will be held virtually. The announcement, agenda and packet for the business meeting will be published shortly.
- Board elections will be held by all electronic ballot, just as was done in 2020. Watch for details coming out this week. The election committee will meet virtually October 7, 2021 at 8:00 a.m. to count the votes and certify the election (just before the annual business meeting).
- The Board meeting scheduled for in person October 8 at 7:30 a.m. will be held on October 8 at 11:00 a.m. virtually. The meeting agenda and packet will be published towards the end of September.
- The Achievement Awards will be presented during the Annual Business meeting on October 7, 2021 at 9:00 a.m.
- Regional Roundtables are being scheduled for early December (all LAFCo meeting schedules were checked in this planning). Watch for them to be included in the master program schedule.

SPECIAL MEETING

Monday, June 7, 2021

Meeting called to order at 3:00 p.m.

Members present: Kevin Stafford, Mendy Schuster and Chris Gallagher. Absent: Hemphill and Eid.

Staff Present: John Benoit, Executive Officer and Ruth McElrath, Building Permit Technician.

Correspondence: Mr. Benoit gave a brief presentation regarding Calafco Awards.

Approval of April minutes Motion by Commissioner Stafford, second by Commissioner Schuster to approve the April 12 minutes. Motion carries: Ayes: Stafford, Schuster and Gallagher. Absent: Hemphill and Eid.

Public Comment: None

Public Member and Public Member Alternate Recruitment

Mr. Benoit explained that Chair Eid's term is expiring and was advertised in the newspaper and various other places. Mr. Eid responded, and his letter was in the board packet. He stated that there is an alternate vacancy and Mandy Smith applied in the Fall 2020. Mr. Benoit stated he sent an email asking if she was still interested, but he never received a response.

Commissioner Gallagher stated he was comfortable with appointing Mr. Eid and holding off on the alternate vacancy.

Motion by Commissioner Schuster, second by Commissioner Stafford to appoint Mr. Eid to a four-year term. Motion carries. Ayes: Schuster, Stafford, and Gallagher.

Discussion with Fire Agencies regarding fire services going forward in Lassen County

Mr. Benoit explained LAFCo's role is to do changes of organizations and service review on the fire districts' capabilities. There are various alternatives on how to manage fire districts, many of which were formed in the 1940s and 1950s. He continued there is a lot of fear about LAFCos consolidating fire districts, but LAFCo does not have that power, the people have the power in the vote.

He continued there are various types of associations that fire districts may have, such as a joint power authority for EMS, which is the most common. Mr. Benoit said he has worked with a few cities who have JPAs with adjacent fire districts, which is one alternative.

One advantage is there is only one board of directors, one disadvantage is there is a perception you lose local control, but it depends on how the fire districts are organized.

Mr. Benoit stated a MSR was done for Lassen County and LAFCo took the position that while the districts are small, they're independent, and in remote areas, it is hard to have a large fire protection district. He further explained LAFCo suggested that one of the adjacent fire districts take over Herlong, but no one was interested, and as a Public Utility District, Herlong recently formed its own fire department several years ago.

He added that he has done quite a few consolidations because the people and boards of directors wanted it, forcing the issue would be futile. They are also inundated with a tremendous number of state laws and if anyone read the grand jury report on the Standish-Litchfield Fire Department, the grand jury did a good job listing all of them.

Commissioner Gallagher stated the discussion came up after doing a review for the Spalding/Stones MSR and Paul Smith, of the Standish-Litchfield Fire Protection District, suggested there was a need for a county-wide fire department.

Michael Patrick, a public member, asked who would make the decision for getting the item on the ballot. Mr. Benoit explained the process which would include each districts' board of directors passing a resolution, filing an application and business plan with LAFCo, noticing other county agencies, holding a public hearing for the Commission to review. If more than 1000 voters and properties are involved, a protest hearing is set and there requires 25 percent of the registered voters to cause an election.

Mr. Benoit also said another way to consolidate fire districts is if 25 percent of the registered voters file an application with LAFCo, however, it is very expensive and time consuming.

Mr. Smith provided a brief narrative regarding the consolidation going on with Eastern Plumas County's fire districts.

Mr. Gallagher asked Mr. Smith to elaborate on why he brought the recommendation to the board.

Mr. Smith explained volunteers go up and down and all the fire districts have an opportunity to make money. If the money were put into the County coffers, there could be an opportunity to hire several full-time firefighters. Some outlying districts may suffer, whether training, grant writing, and equipment, but Mr. Smith they would have help and there are still things that would benefit those districts.

There was general discussion regarding noticing and Mr. Benoit stated notices have to be published in the Modoc Record since the local newspaper is no longer open.

Tony Shaw, Assistant County Administrator Officer, explained a person can ask the elected body to send a notice of the regular, special and emergency agendas and the clerk of that body is obligated to send an agenda to that person.

Sandy Raffleson, of the Herlong Public Utility District, provided a scenario of what a consolidation would look like if several fire district boards signed resolutions. While the process can get quite hairy, there could be benefits. She continued that if Herlong were to lose its Fire Department, it would lose Prop. 218 funding. People don't like paying more taxes but having a fire department also helps the ISO rating, which helps property insurance.

Commissioner Gallagher told the audience that hopefully that was enough information they could bring back to their boards.

Continued Workshop regarding the Spalding and Stones-Bengard Service Review and Sphere of Influence Update

Mr. Benoit stated both districts provided responses to the draft MSR, and the purpose is to discuss the payment of medical calls when one district goes into another district.

Bob Larivee, Stones-Bengard Vice Chair, cited a list of concerns he had with the report and provided some recommendations. He stated that the recommendation for consolidation would be counter-productive, and he would like to see it removed.

Mr. Benoit said it is a service review of the service district and not the extemporaneous stuff.

Commissioner Gallagher explained he was the general manager for two community services districts and it's that person's responsibility to review the report and correct any inaccuracies.

Martin Balding, former Stones-Bengard General Manager, said he did receive a copy of the report, marked it up and returned it to the board prior to his retirement.

Ken Coffey, of Spalding, stated it is not their intent to infringe or combine fire personnel and he wants to make sure their partnership remains open and helping each other with fire coverage.

Cheryl McCormick, Stones-Bengard president, also provided a few clarifications.

Ryan Barney, Stones-Bengard Fire Department Assistant Fire Chief, explained they have a very small fire department with six volunteers. He opened dialogue with Spalding as they are neighbors in a remote area and they intend to move forward in acting as neighbors.

Cliff Spediacci confirmed the dialogue with Stones-Bengard, and offered to help them anyway they can.

Commissioner Gallagher said the matter came up because LAFCo had received complaints about Spalding responding to calls in Stones because there was no one trained to respond. These special districts have difficulty getting money to respond out of their area especially as far as Stones is from Spalding. The discussion about consolidation had more to do about costs and getting some reimbursement.

Mr. Balding stated it's extremely challenging, with state mandates, rules and regulations it is impossible to operate in this county with the funds we have and actually meet every legal requirement, but we need to meet the public needs as best we can. He thanked Spalding for all the times it showed up to help. The goal is to serve the community to the best of our ability.

Kay Orring, a former Stones Bendgard board member, also provided some comments regarding the report. She added she thought it would be difficult to combine the fire districts without first separating out the service district which provides wastewater.

Public hearing 2021-2022 LAFco budget.

Mr. Benoit explained there were no changes from the proposed budget and final notices were sent to the City and County. The only change is a \$20 decrease in Calafco dues.

Public hearing opened at 4:30 p.m.

No comments.

Public hearing closed at 4:31 p.m.

Motion by Commissioner Schuster, second by Commissioner Stafford to approve the 2021 budget. Motion carries: Ayes: Schuster, Stafford, and Gallagher. Absent: Hemphill and Eid.

Mr. Benoit stated there are LAFCo files that need to be scanned and purged and there is money in the budget for it.

He provided an update on the case San Luis Obispo v. Pismo Beach. He explained LAFCo will not be able to use the indemnity clause anymore because there is legislative authority to do that. The Supreme Court is determining if it will review it and it puts a stay on it. Lassen LAFCo doesn’t have a reserve fund to it wouldn’t get through a year of litigation.

There was a brief discussion regarding where to hold LAFCo meetings. Commissioners were in favor of moving to City Council Chambers.

Public Member and Public Member Alternate Recruitment

Mr. Benoit provided an update on the recruitment, and the Commission directed staff to readvertise the position.

Discussion with Fire Agencies regarding fire services going forward in Lassen County

Mr. Benoit said since last meeting, he read a grand jury report from Sutter County, who is having similar problems that stems from lack of funding and lack of volunteers.

Mr. Benoit continued that there are five districts in Eastern Plumas County that want to consolidate, and a Request for Proposal has been released.

He concluded that fire protection in rural communities is a big problem.

Continued Workshop regarding the Spalding and Stones-Bengard CSD Service Review and Sphere of Influence Update

Kay Oring spoke as an appointed representative of Stones-Bengard, as she explained the board was holding its regularly monthly meeting at that moment.

Ms. Oring said she was disappointed with how her comments were summarized in the June 7 meeting unapproved minutes. She explained her real concern is that in the previous report it stated Spalding wanted to return to receiving compensation if it provided services in Stones. She continued they recently completed purging records and found there was never any formal compensation contract with Spalding, but Stones always gave a donation, and that is what her point was.

At one point, there was the Eagle Lake Special District which included all the communities, Spalding, Bucks Bay and Stones, but it changed by a vote of the people in the late 80s, and Stones has no interest in going back to a combined district, Ms. Oring said.

Stones now has an enthusiastic, young fire chief, and due to the pandemic, younger people are moving to Stones to live full- time, and she believes that will change the complexion of the community.

Ms. Oring said the real issue is the operating budget, and they are limited by the State mandates from Proposition 4. The district didn't have a fire chief for a long time and, they didn't find out until last Fall that mutual agreements hadn't been redone.

Chair Eid clarified that both districts want mutual aid, they want to stay as two separate entities, but both want agreements for when those services are provided and the money flows in both directions.

Ms. Oring confirmed his statements.

There was general discussion regarding LAFCo's role in the matter.

Mr. Benoit commented that contracts and the day-to-day issues are the purview of the districts, LAFCo does not tell them how to operate.

Ms. Oring asked about some of the recommendations in the report, specifically regarding establishing the requirements for future annexations. She said there is no interest in increasing the sphere of influence.

Mr. Benoit responded the proposed sphere is coterminous with the boundaries and he would remove that recommendation because there is no need for it right now.

Ms. Oring asked if she could assure her board that LAFCo would not be seeking consolidation.

Mr. Benoit responded this would be a bad consolidation.

Sheryl Alvernaz, of the Spalding CSD, stated they also do not want to see an enjoining of the two districts or any other district. She continued that LAFCo is required to promote orderly development and collaboration with local officials. She stated she would like the reports to address the legal requirements of board members, following the Brown Act, and filling out 700 forms.

Spalding is having a rough time, Ms. Alvernaz said, and as part of growing and developing, they need LAFCo's help. There are a lot of issues that need to be addressed and LAFCo's report is the only one that goes to these districts. She said she would like to see some structured and measurable ideas in the MSR/SOI that the board can follow.

Sandy Raffleson, of the Herlong Public Utilities District, stated the California Special Districts Association currently has open enrollment for free membership, and they can certainly help.

Mr. Benoit also added 2020 Lassen County Grand Jury Report had a report about a local fire district and there was a good laundry list of what fire districts are supposed to do.

The Commission and audience held further discussion regarding Spalding needing help and LAFCo's role.

Mr. Benoit stated LAFCo has a lot of authority when a district changes its boundaries and have some power to deny or make changes.

Chair Eid recommended they should speak with their supervisor who can assist in different ways.

The Commission will hold another workshop regarding the item.

Resolution changing location for Lassen LAFCo regular meetings

Motion by Supervisor Hemphill, second by Commissioner Schuster to approve Resolution 2021-0003, changing the regular meeting location to the Susanville City Council Chambers for Lassen LAFCo regular meetings. Motion carries: Hemphill, Schuster, and Eid. Absent: Stafford and Gallagher.

Discussion regarding Policy Amendments: Indemnification Agreements and Application processing timelines and provide direction to staff

Mr. Benoit explained if an applicant sues LAFCo based on a decision it made, LAFCo cannot require the applicant to pay its attorney fees, and LAFCo would be on the hook for its own legal costs. The Supreme Court denied review of the case.

One remedy is having a large reserve fund, however, LAFCo got rid of its reserve fund about 10 years ago. If we get sued, there will be a budget deficit for years to come, and the County and City will ultimately have to pay it.

Calafco is proposing legislation to get LAFCo's to enter into indemnity agreements.

Mr. Benoit continued that Lassen LAFCo is probably not an issue unless a developer doesn't like its decision. He also added if they did deny a project and got sued, they can choose to not defend it.
